1. Opening and Introduction

The meeting opened at 2:05 PM. Dominic Butchko (MACo) called a roll of all currently known designees and established a quorum.

Robert Ruffins, Policy Director, Maryland Department of Labor, Division of Workforce Development and Adult Learning (DWDL) joined the Commission membership as designee for MD Department of Labor.

Logan Dean, Policy Analyst, Maryland Department of Labor, Division of Workforce Development and Adult Learning (DWDL) has been assigned to staff the Commission in accordance with SB414.

2. Selection of Commission Chair and Subcommittee Chairs

Prince George's County Fire Chief Tiffany Green was nominated to serve as Chair of the Commission. The Commission unanimously approved the nomination of Chief Green as Chair.

Kate Loveless, Executive Director, Maryland State Firemen's Association was nominated to serve as Chair of the Volunteer Subcommittee. The Commission unanimously approved the nomination of Loveless as Volunteer Subcommittee Chair

4. Understanding the Workforce: Designing a Survey

Logan Dean, Policy Analyst, MD Department of Labor, proposed conducting a survey to assess the fire fighting and EMS workforces in Maryland. The survey would be modeled after a survey conducted by MD Labor with local correctional agencies and police departments in 2022. The survey would be administered voluntarily to participating departments, including individual staff members and volunteers. Commission members will work to design and approve the survey questions and delivery.

The Commission discussed important questions and issue areas of interest for the survey:

Funding sources, investments Volunteer side: grants for recruitment and retention Diversity and inclusion Mental and physical wellness What current programs are used to recruit? Incentive programs, bonuses Retention of a volunteer into a career High school programs Age of volunteers and careers

When the Subcommittees convene in July a survey will be designed and approved for release to participants. Anticipated survey release is early July, with responses due at the end of the month.
